Consent for Criminal Background Check Authorization/ Waiver/Indemnity

Each employee, employee applicant, contractor, volunteer or volunteer applicant who is to be screened, must sign an authorization/waiver/indemnity form giving approval for the City of Reno to perform the criminal background search.

I hereby give my permission for the City of Reno to obtain information related to my criminal history record. The criminal history record, as received from the reporting agencies, may include arrest and conviction data as well as plea bargains and deferred adjudication. I understand that this information will be used in part to determine my eligibility for an employment/contract/volunteer position with the City of Reno. I also understand that as long as I remain an employee/contractor/volunteer with the City of Reno, the criminal history records check may be repeated annually per city policy or for reasonable cause. The employee/contractor/volunteer will receive prior notice of any such repetition unless such notice, in the opinion of the Reno Police Department, would compromise an ongoing investigation. I understand that I will have an opportunity to review the criminal history and a procedure is available for clarification if I dispute the record received. Additionally, there will be no disclosure of any sort of the results of such investigation by any person associated with the City of Reno. No publication or disclosure of any sort of the results of any such investigation may be made at any time except upon prior written consent by the employee/contractor/volunteer.

I, the undersigned, do, for myself, my heirs, executors and administrators, hereby remise, release and forever discharge and agree to indemnify the City of Reno and each of their officers, directors, employees and agents and hold harmless from and against any and all causes of action, suits, liabilities, costs, debts and sums of money, claims and demands whatsoever, and for any and all related attorneys' fees, court costs or any other expenses resulting from the failure of the employee/contractor/volunteer to truthfully respond to any questions involved in this application or for the concealment of any items subject to the above criminal background search.
