Mayor Hunter said he wasn't saying Walt Leonard took measures – but this is highly unethical.

Walt Leonard said if he had try to set the case or do anything to affect the way it was being handled – the Judge – the Court Administrator – the Director of Public Safety would never have tolerated anything of the sort not would he have ever done it.

Mayor Hunter said an easier answer would be he can't dictate.

Walt Leonard said he thinks Bonnie Black knew it. He said he guessed Mayor Hunter didn't.

Mayor Hunter said when Walt Leonard said it is best to have this hang over her head.

Walt Leonard said yes as a joke he said yes he remarked it could happen. He said as he remembers Mayor Hunter was campaigning for Bonnie Black at that time.

Mayor Hunter said at that time he did support her. He said since then his eyes have been opened. He said he stopped everything people were telling him and he went and did research.

Walt Leonard said if he did research he would have found out he couldn't do anything about it. He said even more frustrating recently he has been told by Mr. Basham the dog was indeed vaccinated.

Mayor Hunter said they aren't trying anything just pointing out

Walt Leonard asked why didn't he

Mayor Hunter asked Ramah Burns how many Ordinances are we waiting on and how much time has passed.

Scott Passmore said probably 12-13 and some were when Lynda Stokes was leaving office.

Mayor Hunter said Ordinances passed under the former Mayor still haven't been written. He said he has asked him twice for them and he still hasn't provided them to us. He said he put a limit on how long people could use the City Attorney to try and curve some cost – he got that Ordinance out in 24 hours.

Walt Leonard said he has received several things from Scott Passmore. He said he expected to hear more detail and receive more information that was needed. He said he has always called before every council meeting and asked the Mayor what do we need for the meeting. He said this has never been mentioned. He said he was waiting for more information.

Mayor Hunter said he talked with Walt twice in his office before the meeting.

Walt Leonard said he calls and asked what do they need and there was never an answer on that line. He said another problem in the last 6 months is nobody has been talking to time. He said that has been a problem. He said he has been more or less abandoned out there. He said the information he received was not sufficient to carry out some of these ordinances and wasn't at the time when they passed them. He said he was waiting for more information and they will remember when they talked about he believed in a council meeting a few month ago he indicated some of these will probably need to be reviewed. He asked do we want to still pass them or have something different and he has never ever heard from anybody about that.

Mayor Hunter like he said he told Walt Leonard twice – once standing in his office before a council meeting. He said Scott is waiting on ordinances and he thought one of his responses was well I may have sent some to Lynda so she may have them. He said he told him if he did them obviously you have copies so get them to Scott.

Walt Leonard said he sent some notes and Lynda and he discussed them fairly frequency but he is still waiting on some finality and therefore he needed help to do some of these things and he doesn't exist in a vacuum.

Mayor Hunter asked could he of ask for help.

Walt Leonard said he probably could have.

Mayor Hunter asked was it something Scott needed to do direct him on or he needed to direct him on..

Walt Leonard said some of the stuff he was waiting on was from Scott far more than what he received. He said he has never heard about the 12 Ordinances. He said they may have not gotten them to him remember was ill earlier this year. He said he knows in recent months he didn't want to bother him but Scott had a probably with his teeth. He said so at this point as far as the Ordinances are concerned he was basically waiting for other material. He said he did ask Mayor Hunter each month what do we need to do for this month and what do we need to do – what's on the schedule – and never was a mention was made.

Mayor Hunter said he is going to point out again that he did point it out to him twice.

Walt Leonard said it was specific as to what we needed to do at that time and he was still waiting for other materials.

Mayor Hunter said Walt would call and ask him what we needed for the agenda which they didn't. He said what they needed were all of the past ordinances.

Walt Leonard said he asked to put them on the agenda.

Mayor Hunter said he can't put them on the agenda if you haven't given them to us.

Walt Leonard said we can put them on the agenda then we will have them when we get them. He said no one ever said let's bring it back for review.

Mayor Hunter said still not on paper for review.

Walt Leonard said if they are going to have it on review then that's the time to do it. He said he was waiting for some back ground and some assistance because apparently he has become persona non grata in the last six (6) months or so. He said he wasn't getting a lot of help and support which he expected and never got.

Mayor Hunter asked who Walt Leonard asked. Who did you say this is what I need? Did he ever say Eric I need this from Scott because he had Scott saying he needed this from Walt. He said he in turn told him Scott needs these ordinances.

Walt Leonard said he got the impression the last few months he wasn't supposed to be talking to pretty much anybody. He said no body seems to want to talk with him.

Mayor Hunter said he tried to curve Walt's expenses — yes. He was trying to cut some costs for the city.

Walt Leonard said this wouldn't have affected that.

Mayor Hunter said we got an ordinance pretty quick for that did he.

Walt Leonard said it was needed for immediate use.

Mayor Hunter said it was needed for his paycheck is what it was needed for.

Walt Leonard said he doubted that. He asked how it would be needed for his paycheck.

Mayor Hunter said because Walt wanted to help them to limit his authority to limit his usage.

Walt Leonard said that he couldn't do because of the way the contract is written.

Mayor Hunter said the one Walt wrote.

Walt Leonard said the one that was requested by the council. In regards to the contract -

Mayor Hunter said he has no right to try and cut cost for the city and try and save some money.

Walt Leonard said of course he did but that wasn't part of what it had to do with the contract. He said the contract specified — everybody needs to realize — that's another thing that is goofy in that letter that was sent to the other attorney. He said it has been an ongoing thing he guesses that supposedly he has said to the Mayor — he guesses this Mayor - there are contracts then there are contracts. He said that is absolutely true. He said what he meant was there are many types of agreements.
