1. Call to Order and announce a quorum is present.

All Council Members were present. Meeting was called to order at 5:34 pm.

4. Mayor's Announcements

Mayor Hunter said the October 27<sup>th</sup> Fall Festival next meeting will be on September 11<sup>th</sup> at 3:45pm. The next rabies clinic is in November 2018.

Councilman Trammell said his wife Helen had hip replacement and everything turned out perfect. He thanked everyone for their prayers.

Mayor Pro Tem Basham said someone went to the residents that live on Jennings Lane and lied telling them the city was going to annex their property. The city cannot take anyone's property. 
